- 1) **Sealed Tender** along with documents and **Annexure 'B' duly filled** to be submitted to us by 3:00 PM, 17<sup>th</sup> March, 2021 in a sealed envelope super scribing it, "**Tenders for refilling of fire Extinguishers at Webel IT Park – Durgapur (Phase - I)**"
- 2) Tender to be submitted in two parts i.e. Cover-I and Cover-II separately, sealed and superscribed with the name of the work.
  - ❖ Cover-I : Forwarding letter, Tender Cost, EMD, Tender Document duly filled(without price bid), Signed-sealed copies of all aforesaid credential in similar works and statutory documents
  - ❖ Cover-II: Shall contain the offered price (Annexure - B of the Tender Document) duly filled with hand written. No other condition stipulated in Cover-II, other than unconditional general rebate, shall be accepted. All pages of the Tender Document should have original signature with seal of the tenderer.
- 3) Cover-I will be opened on 17.03.2021 at 3.30 P.M. onwards in presence of WBEIDC officials and Tenderers who desire to attend. After examining the Cover-I of the tender, WBEIDC will only open the Cover-II of the successful tenderers who have satisfy the requirement of Cover-I.
- 4) The rate should be quoted inclusive of all Taxes, duties, levis etc. also including removal & positioning of extinguishers from and to the existing places after refilling and including transportation charges. Accordingly fill up **Annexure B (BOQ)** quoting price and submit duly signed and sealed with reference no.
- 5) All the Fire Extinguishers of type mentioned in **Annexure -B** should be refilled with their appropriate BIS standard (**relevant IS**) for their quality/reliability with proper testing & filling and also certificate should be submitted. Demonstration of any cylinders (at random) of each type may be tested before releasing the bill. Cost of said Demonstration will be paid extra.
- 6) You have to take up the job immediately after getting the LOA and the job should be completed within 30 days.
- 7) Quantity of Fire extinguishers may increase /decrease but rate will remain same.
- 8) You must submit your PAN, GSTIN, Trade license for fire extinguishers manufacturing/refilling etc (Please mention in the check list of "**Annexure-C**". )
- 9) Bidders engaged with WBEIDCL for any AMC/Installation of Fire Fighting work and having execution of similar nature of job in Govt./ Renown Pvt. Comapny (supporting documents to be submitted) are requested to participate in the tender.
- 10) Payment will be made after completion of the total job and on submission of Bill and challan etc. Security deposit 10% to be deducted and to be refunded after 1 year on satisfactory completion of work. 1% labour cess will be deducted from the bill.
