01. The bidder should submit the Tender Documents duly filled in the format of **Annexure 'A'** to us by superscribing on the envelope "Making Shirts & Pants for 139 male workers for conservancy ,Gardeners, Electricians, Liftman, Pumpman for Webel Bhavan, Monibhandar, SDF, STP-II.TIE Bldg. etc. including supply of dress materials
02. The rate should be quoted inclusive of all taxes, duties, transportation, delivery levies, etc. Accordingly, fill up 'Annexure - A' by quoting item wise price and submit it duly signed and sealed.
03. Submit PAN, GST Regn No. etc.
04. Supporting documents of execution of similar nature of job in Govt./Semi Govt./KMC/reputed large Organisation must be submitted.
05. The successful bidder will be paid against submission of Invoice along with Challan etc. after delivery of the dress to the workers. **No advance payment whatsoever in nature will be made to the Agency.**
06. The quoted rate should be firm throughout the period till you handover the total dress.
07. Payment will be made after completion of the job and submission of bill along with delivery/hand over receipt. Any statutory payment, if applicable, will be deducted at source.
08. **Security deposit (S D) 3% and labour cess 1%** will be deducted from bill. However S D shall be refunded after satisfactory completion of 1 year warranty period.
09. **Tender fees Rs 100.00 (one hundred) & EMD Rs 1500.00 (one thousand five hundred) by DD/pay order** in favour of W.B.E.I.D.C.Ltd., are to be submitted.
10. Measurement of shirts & trousers of male workers are to be taken by the successful bidder / party at Taratala office & Salt Lake offices separately.
11. **Brand name and the identification numbers of the clothes have been mentioned in the Bill of Quantities.** Samples are also kept at our office at Webel Bhavan. If any bidder wants to see it, the bidder may come to our office on any working day.
12. You may collect the tender papers from the office of GM(ID&M) at Webel Bhavan daily on working hours.
13. The shirt & trouser should fit well & natural Movement, Personal comfort is to be taken care of.
