SCOPE OF WORK

1. Routine checking & servicing of the A.C Split/ Cassette type units should be carried out, **once in a month** and your job card / call book / service register should **definitely be signed by our representative** for each service rendered and checking & servicing shall cover with :-
 - a) Checking the pressure of both suction and discharge of the compressors
 - b) Inspection for leaks in the refrigeration and drainage system.
 - c) Checking performance of all controls and adjustments, if necessary
 - d) Cleaning of Air Filters
 - e) Cleaning of Condenser with Air Blower / Compressed Air
 - f) Cleaning of Evaporator Coil
 - g) Checking of Grilles, Diffusers and Dampers for proper Air flow
 - h) Cleaning of Condensate Drain
 - i) Checking of Electrical Connections of the machine terminals and also to inform our representative when signing your job card, of such terminal failure for proper action.
 - j) Oiling of rotating parts as required.
 - k) Painting of out door unit & its stand once in year.

2. Maintenance Contract is purely covered with all the parts / equipment of IDU & ODU and its accessories, pipe lines, electrical connections, hence timely supply of men, materials or spare parts and arranging gas charging, **replacement of old / damaged compressor** by new compressor within 48 hours is also included / covered in the AMC. No additional charge/cost will be given.

TERMS & CONDITIONS

Comprehensive Maintenance/Service Contract of our AC Split / Cassette type machines at different units will be under the following terms and conditions :-

1. Maintenance & Overhauling may be done at site or at your service center as deemed fit.
2. The Firm should have service set up at Kharagpur area or nearby location.
3. You have to attend calls from us immediately any time both on working hours & non-working hours as required and no extra payment is to be made. Accordingly, you have to provide / mention **name of contact person and Phone nos.** in addition to service centre.
4. The Contractor / vendor should have statutory documents like GST, PAN, PF, ESI etc. and completion certificate issued by the Client (Govt. Organization or Reputed Private Company) indicating date and performance remarks.
5. The Contractor / vendor have to sufficient & competent work force (including licensed electrician) to cope with the requirement, capable to work parallel at different sites at a time and have the experience to do the maintenance contract of reputed organization and please enclose credentials positively while depositing tender papers.
6. If you do not have sufficient work force, please do not quote for tender. Sub-contracting will not be allowed.
7. If we buy new machines during the contract period from you or any other makers, then after the warranty period those machines will also to be added in the contract and will continue till the end of the tenure at the same rate.
8. The firm / agency must be enlisted contractor of PWD/CPWD/KMC/Govt. Org./Reputed Pvt. Org. and manufacturer of Air conditioning machines and also authorized sales & service dealer of Hitachi or equivalent (Authorization certificate need to be attached).
9. Without showing any reason what so ever, **Corporation** may discontinue your service and the contract any time and for which you will be given One month notice and you have to make pro-rata refund of unexpired portion of advanced contract value.
10. For any reason, you want to discontinue your service and the contract, then you have to give “three” months notice to Corporation for such withdrawal.

11. Earnest Money deposit (EMD) of ₹1,000.00/- (One Thousand only) is required to be submitted by Demand Draft /Pay order/Banker's Cheque by all the tenderer with the tender in favour of WBEIDC Ltd payable at Kolkata. EMD deposited by unsuccessful tenders will be refunded. No interest will be paid on EMD.
12. The tenure of contract will be initially for one year from the date of placement of the work order. The period of contract may be extended for another term of one year or multiple of it against the prayer from the agency. However, the same depends on the contractor's satisfactory services / performance although the decision of the management in this respect is final.
13. Payment will be made on expiry of a MONTH OR QUARTER (3 months) against your bill & along with job card/attendance etc. within 15-30 Working days.
14. The rates and duties fixed throughout the contract period will remain unchanged.
15. Any others statutory payments, if applicable, will be deducted at source.
16. You will be paid extra for any removal, delivery and change of location of machines, if required.
17. You will also ensure proper operation of Air-conditioner.
